## **OLD BUSINESS**

**Public Comments limited to 3 minutes per individual:** The question of whether we should pursue a cross country ski trail was raised.

**Approval of Minutes** of regular meeting Sep 21, 2020. Tim Gallagher moved to approve. The motion carried unanimously.

**Sale Lots 7 & 8:** We have received a backup offer of \$250,000 for Lot 8 (which is currently under contract for \$239,000). Kim Kron motioned to counter the offer at \$258,500 as advised by Shelley Low, our realtor. Gary Franklin seconded. All approved.

Tim Gallagher motioned to perform a certified resolution to accept the standing contract for \$239,000 which is required due to our status as a Metro District. Gary Franklin seconded. All approved.

**Financial Statement Review:** Bob Milford presented the September 2020 financial reports and 2021 budget. Reports will be posted to the website.

Approval of the 2021 budget will occur in the November meeting.

**Road Maintenance Plans and Cost review**: Discussion of the communication draft to be sent to the community regarding the 2021 budget as well as the proposal to raise the mil levy to build a reserve for future road maintenance was held.

**Timber Ridge Trails:** An update of the construction progress of the trails was provided. Construction is progressing as expected. The trail will not extend into Tract 'O' as was the original intent.

**Paint Fire Hydrants:** This effort was successfully concluded with overwhelming volunteer effort from the community.

**Prairie Dog Control:** No update as the effort will not be pursued until early spring.

**Traffic Study:** No update – last discussed in the June 15, 2020 meeting.

Additional Large Package Box: No update – last discussed in the Sep 21, 2020 meeting.
